Education - MCN provides timely and relevant educational events, networking opportunities and publications to strengthen individual organizations and thus the sector's effectiveness, productivity and accountability. In 2013, MCN sponsored 75 educational workshops and six conferences on a wide range of topics, including financial management, human resources, fundraising, communications and leadership. Over 5,000 individuals attended these training events in 2013 including 867 registrants for the 2013 Nonprofit Technology and Communications Conference and 661 registrants for the Annual Conference in Duluth. MCN also hosted seven free networking sessions per month on management, human resources and communications in the Twin Cities and northeast, central and southern Minnesota. In 2013, MCN also continued its role as

Public Policy and Civic Engagement - MCN builds the capacity of nonprofit leaders to be confident and competent voices on issues impacting their constituents and communities by providing them with workshops, briefings and other informational resources. In 2013, MCN offered a substantial public policy training and information series attended by several hundred participants that included topics like basic and advanced nonprofit advocacy, lobbying laws, state and federal budget processes, media advocacy, evaluating advocacy and building strategic relationships with public officials. In 2013, in an effort to reduce barriers to participation, we offered nearly all of our advocacy training events through free webinars.

4c (Code:) (Expenses \$ 350,724. including grants of \$) (Revenue \$ 735,924.) Member Services - In 2013, 2,281 charitable organizations and 194 businesses contributed dues to support MCN's work. Members receive discounts on publications, workshops and conferences and can participate in special cost-saving programs. MCN hosted its third annual member appreciation month in August 2013 and celebrated members at special networking events in St. Paul, Mankato, St. Cloud and Duluth. MCN staff also participated in a "thank you" call-a-thon, reaching out to members over the phone to thank them for their work. MCN also capitalizes on the buying power of its members to negotiate lower prices and better service on many products and services that nonprofits need, including banking, insurance, employee benefits, office supplies, payroll processing and more. Deferred tax assets are recognized only to the extent that it is more likely than not that they will be realized based on available evidence.
